<sup>4</sup>W refers to a waived course; CU Core requirements are waived for students with Associate Degrees from schools with which Centenary University has an agreement

<sup>5</sup>Statistics I cannot be waived, as it is a prerequisite for Business Statistics

<sup>6</sup>Remaining CCAF transfer credits will apply towards *some* of the free elective requirements and *may* apply towards other required courses. Any Centenary University course may be selected from the catalog and course schedule to be used as electives, provided that they are not used to satisfy other program requirements. Free elective credit cannot be granted for courses for which the student has already received credit by examination, has received a passing grade in a comparable course, or has transferred in credit for a comparable course.

#### B.S. in Business Administration Degree Requirements:

- Must successfully complete a minimum of 120 credit hours.
- A minimum of 30 credits must be taken at Centenary University.
- Must maintain an overall cumulative GPA of 2.00 or above.
- All graduates must have a minimum 2.0 GPA in their major(s).
- Credits can only be shared between the core and the major. Shared credits within the core requirements is not allowed.
